Friends, today I offer some insight to law abiding citizens on avoiding half of all legal problems. Under our common law tradition, civil actions can be divided roughly into two categories: tort and contract. Injury for negligent conduct, such as may be involved in an automobile or boat collision, gives the injured party a cause of action in tort. Injury from breach of contract, such as incomplete repair work, improper repair, defective goods, nonpayment, supply of or unworkmanlike performance, gives the injured party a cause of action in contract. Listen to me very carefully. You can choose the party with whom you contract. You cannot always pick the person who will cause a car wreck, but you can always choose the party with whom you contract. If you choose to do business with crooks, or litigation freaks, legal problems will follow. But you can choose to do business with reputable persons or firms with a track record of avoiding litigation.

In summary, to avoid contract disputes do business only with good people. This will avoid legal problems more effectively than any contract language ever drafted by a lawyer.
